1. 4. I understand that my authorising agent can terminate my engagement if I fail to meet my commitments as set out on this form and I agree that upon termination I will promptly deliver my Authorisation Card to my authorising agent.
5. I agree that if any complaint of sexual misconduct is made against me, my authorising agent may suspend my engagement immediately until such time as the matter is resolved.
6. I agree that my name, address and phone number may be provided to PYNSW to enable them to provide me with relevant SRE information.
7. I agree to only use an authorised SRE curriculum as shown on this form.
8. I agree to carry out my task as an SRE Teacher in accordance with the conditions of this form.
